- Includes 157,438 restricted stock units ("RSUs"). Each RSU represents a contingent right to receive one share of Issuer's Class A Common Stock upon settlement.
- The sales reported on this Form 4 were effected pursuant to a Rule 10b5-1 trading plan adopted by the Reporting Person.
- The price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$38.825 to \$39.55, inclusive. - Each share of Class B Common Stock is convertible into one share of Class A Common Stock at the option of the holder and has no expiration date.

- The shares are held of record by the Reporting Person's spouse as custodian for the benefit of her minor child.
